

Sir,

It has been reported by the Custodians especially those of English language, Commerce, BBM etc. units of UG Examination of December 2018 that the teachers who have been drafted for evaluation work are not attending to the evaluation work in spite of several requests by the Custodians thereby causing undue delay in the valuation work.

As you are aware, as per Chapter 13, Section 74 of KSU Act 2000, and Bangalore University Examination Ordinance 2011, evaluation work is mandatory. Therefore, you are hereby requested to instruct the teachers concerned of college to attend to the evaluation work forthwith failing which it will be viewed seriously and action will be initiated as per Bangalore University Examination ordinance 2011. Also, in case the colleges fails to send the teachers for evaluation, the results of such colleges will not be processed.

You are therefore requested to kindly depute all the teachers who have put in 3 years of full time service to report for valuation everyday including Sunday and to withhold the salaries of teachers for the Month of January 2019 of Aided and Government Colleges who abstain for valuation work.

In this office Press Note dated: 04-01-2019, it was informed that the valuation work of 1<sup>st</sup>, 3<sup>rd</sup>, 5<sup>th</sup> and 7<sup>th</sup> Semester UG Examinations of Nov/Dec- 2018 have commenced from 31<sup>st</sup> December 2018 at the valuation centers identified for each Semester/Course. The University has already dispatched appointment letters to the eligible valuers to report for valuation work.

However, it is observed that there is a thin attendance of valuers attending to the evaluation work, inspite of repeated requests by the Custodians/BOE Chairpersons concerned, thereby causing undue delay especially those of English language in the valuation work. As per Chapter 13, Section 74 of KSU Act 2000, evaluation work is mandatory. Therefore, all the Principals are hereby requested once again to relieve the eligible teachers concerned of their college with instruction to attend the evaluation work, failing which it will be viewed very seriously and action will be initiated as per Bangalore University Examination Ordinance 2011. In case, the college fails to send the teachers for evaluation, the results of such colleges will not be processed and also initiate disaffiliation process against such colleges and attendance certificate to be issued by Registrar (Evaluation) for the valuation work done by the teachers.

Besides, the Commissioner, Collegiate Education will also be informed to withhold the salaries of teachers of Aided and Government Colleges who abstain for valuation work.
