## NOTIFICATION

**Sub: Inviting applications for affiliation for the year 2021-22-reg**

**Ref: 1.** Government Order No. ED 34 EGOV 2020 (Part-2) dated:10-06-2021  
**2.** Approval of the Vice-Chancellor dated: 30-06-2021.

Bangalore University invites applications for various types of affiliation as prescribed in Sections 59 and 62 of the KSU Act, 2000, from the affiliated Colleges/ Managements situated in the Bangalore University jurisdiction as specified in the Karnataka State Universities (Amendment) Act, 2015 i.e., Karnataka Legislative Assembly constituencies of Vijayanagara, Padmanabhanagar, Bommanahalli, Anekal, Bangalore South, Yeshwanthapura, Rajarajeshwarinagar, Dasarahalli, Mahalaxmi Layout, Govindarajnagar of Bangalore Urban District, Nelamangala of Bangalore Rural District, Magadi, Ramanagara, Kanakapura and Channapatna of Ramanagara District for the academic year 2021-22.

Colleges/Managements have to submit the applications through online 'https://www.onlineaffiliation.karnataka.gov.in/Affiliation2122/login.aspx' and applications will be processed as per the Government Order No. ED 34 EGOV 2020 (Part-2) dated:10-06-2021 and the norms / standards, criteria as stipulated in Government Order No. ED 29 UNE 2021 dated:12-02-2021/16-02-2021 and UGC (Affiliation of Colleges by Universities) Regulation, 2009.

*Colleges/Managements should have the infrastructures as per the parameter as prescribed by the State Government.*

### 1. RENEWAL OF AFFILIATION/ CONTINUATION OF TEMPORARY AFFILIATION(ETA):

Applications are invited for renewal of affiliation to the existing courses, additional courses and enhancement of intake in the existing affiliated Colleges under the Faculties of Arts, Science, Commerce and Management and Education. The Colleges intending to apply for renewal of affiliation/ enhancement of intake to BHM, MBA, MCA should obtain prior approval of AICTE, for BASLP, MASLP or B.Sc./M.Sc.(Speech & Hearing) from Rehabilitation Council of India for B.Sc.-B.Ed./B.A.-B.Ed.(integrated)/B.Ed./B.P.Ed/M.Ed. colleges from NCTE as applicable.

**NAAC Accreditation:** As per the State Government Circular No. ED 76 UBV 2011 Bangalore dated:17-05-2011 and the University Circular No.Aca-III/NAAC/2011-12 dated:09-06-2011, the Colleges which have completed 5 years are informed to adhere to the standards circulated by NAAC compulsorily and obtain a minimum of 'C' grade. The Principals of all the colleges have to make efforts to adhere to the directions of the State Government issued from time to time. *Renewal of affiliation to such colleges for the academic year 2021-22 is subject to NAAC accreditation of 'C' grade.*

### 2. AFFILIATION OF ADDITIONAL COURSE:

The Colleges can apply for affiliation for starting of additional courses under the Faculties of Arts, Science, Commerce & Management and Education. Colleges should seek affiliation to only approved combinations of UG courses. List of approved combinations is posted in the University Website.

For starting of P.G. courses: Colleges which have continuation of affiliation to UG courses for a minimum period of 2 years (except MBA course) and having good infrastructure facilities, qualified faculty are eligible to apply for fresh affiliation to start P.G. programmes. The Govt. Colleges should have prior permission from the Dept. of Collegiate Education, Govt. of Karnataka to apply for P.G. Courses.

### **3. ENHANCEMENT OF INTAKE (II):**

The Colleges can apply for enhancement of intake to courses under the Faculties of Arts, Science, Commerce & Management. In case of P.G. courses, colleges should note that they shall not seek enhancement of intake to P.G. course more than the intake fixed in the University P.G. Department of Studies as per the general resolutions of the Academic Council dt:1/3-06-2013 and Syndicate dated: 04-06-2013. Intake of courses at P.G. Departments has been given in the PG admission prospectus of Bangalore University which has already been posted in the University website.

### **4. FRESH AFFILIATION TO START A NEW COLLEGE (NC):**

The Managements/Societies/Trusts registered under Societies Registration Act/Trust Act, are eligible to apply for Fresh affiliation to start new Colleges (approved courses/combinations only) in the Bangalore University jurisdiction.

As per the Government Circular No. ED 218 UNE 2020 dated:24-08-2020, it is made mandatory that the Managements/colleges which are seeking fresh affiliation have to submit the certificate issued by the Public Works Department for having complied with the conditions of National Building Code and Fire Safety Certificate from the Fire Services Department for getting affiliation. Further, they have to submit the copies of Registered Trust Deed, Sales Deed, SC/ST Management Certificate, Legislative Assembly Constituency Certificates (in case of border areas of legislative assembly constituency) if any for verification before applying through online. **Affiliation requests submitted through online and fee paid without the above said documents will not be entertained.**

Note: 1. Managements/Society/Trusts are not permitted to apply for affiliation to B.Ed./B.P.Ed. course as per the NCTE directions. 2. Only existing colleges are permitted to apply for P.G. Diploma, Diploma and Certificate Courses.

### **5. PERMANENT AFFILIATION/CONTINUATION OF PERMANENT AFFILIATION (EXCLUDING P.G. COURSES):**

**Fresh Permanent Affiliation (FPA):** As per Section 62 of KSU Act 2000, the colleges affiliated to Bangalore University continuously for a period of not less than 5 years and fulfilling the conditions of affiliation and attained the academic and the administrative standards on an average stipulated by the University from time to time shall be eligible for grant of permanent affiliation. As per G.O.No. ED 37 UBV 2007 Dt: 9-4-2007, colleges must be accredited with 'C' grade by NAAC.

**Renewal/Continuation of permanent affiliation (RPA)** - The colleges which have completed term/s of Permanent Affiliation shall apply for renewal of permanent affiliation.

The Govt. vide Circular No. ED 227 URC 2017 dated: 07-07-2017 have specified the period of permanent affiliation as 5 years, 4 years and 3 years for the colleges which have been accredited with A, B and C grade respectively by NAAC.

**Extension of permanent affiliation (EPA)** - Colleges already having permanent affiliation should submit the application through online portal indicating the permanently affiliated courses in the Extension of Permanent affiliation with the prescribed annual fee.

### **6. SHIFTING /CHANGE OF NAME/CHANGE OF MANAGEMENT ETC.,**

Requests for Shifting of Colleges, Change of Name/Management, will be considered u/s 59(5) of the K.S.U. Act, 2000. Copies of the relevant documents such as, a) Resolutions of the Governing Body/Trust of the colleges, b) Building plans, Sale/Lease deed, c) NOCs from other Departments, if any, etc., as required, along with prescribed fee.

Further, colleges applying for shifting, should submit a compliance of fulfilment of NBC (National Building Code) for the building from the Public Works Department and Fire Safety Certificate from the Fire Services Department along with the applications.

Note: Colleges/Managements should note that the permission for Change of Name/Management etc., has to be approved by the State Govt.

## 7. CLOSURE OF COURSE/COLLEGE.

Colleges not willing to seek temporary affiliation for a course/s, such course/s should be filled under closure of courses column through online application.

## 8. AFFILIATION/APPLICATION FEE AND SUBMISSION OF APPLICATIONS:

The affiliation fee as notified in the Notification No. Aca-III:A3:Affln.Fee Structure:2020-21 dated: 03-09-2019 (For SC/ST Colleges/Managements, affiliation fee payable is 50%, as per Government Order No. ED 21 UBV 2004 Bangalore dated:15-5-2004) has to be paid through on-line University Fee Payment link, available in the website <http://bangaloreuniversity.ac.in/>. The online portal for fee payment will be opened from 05-07-2021 and payment should be made through online transfer, Net Bank/Debit/Credit cards. **Payment through DD will not be accepted.**

Application fee - a) Renewal of affiliation /Additional Courses (Rs.1,000/-), b) Enhancement of intake (Rs.1,000/-) c) Permanent/Continuation of Permanent affiliation (Rs.2,000/-) and d) Starting of New College (Rs.2,000/-), e) Starting of Integrated B.Ed. Course (Rs.2,000/-), f) Shifting/ Change of Name/Management (Rs.1,000/-)

After successful submission of the application in the online portal, hard copies of the applications along with the uploaded/supporting documents be submitted in person or speed post, in 6 sets with the document/challan of affiliation/application fee on or before **14-07-2021** (4 P.M.) and with late fee of **Rs.1,000/-** up to **20-07-2021 (4.P.M.)** at the 'Office of the Registrar (Academic Section – III), Bangalore University, Jnanabharathi Campus, Bengaluru-560 056'.

**Note: (1) Refund of affiliation fee is as per the revised Statutes pertaining to affiliation of colleges/Institutions of Bangalore University.**

**(2) Fee paid by the college towards in-eligible courses will not be refunded/adjusted.**
