

**THE SCOPE OF WORK REGARDING MARKS CARD PRINTING AUTOMATION (UP-GRADATION OF SOFTWARE) FOR THE EXAMINATION BRANCH, BANGALORE UNIVERSITY EXAMINATION SECTION**


The Bangalore University Examination section is in requirement of printing module (up-gradation of marks card printing software) for the marks cards of present, old and new marks cards. The module has to be integrated with present Examination section system software, which is in oracle 11g/12c & forms and reports.

The marks cards printing should have two main sub modules

- UG marks Card printing
  - General courses
  - B.Ed.
  - B.E / B.Tech (CBCS scheme)
  - Other if any
- PG Marks Cards printing
  - General courses
  - M.Ed.
  - M.Tech (CBCS scheme) / L.L.M/M.Sc/MCA/M.B.A/M.Com
  - Other PG – B.Sc/M.Sc ( 5 years Integrated course)
- Supplementary marks cards
  - PG – M.EdM.Tech (CBCS scheme)/L.L.M
  - UG including B.Ed (Integrated course)/ L.L.B/B.H.M/B.B.M


Other conditions in the marks cards printing module.

- Marks cards reports
  - Total marks cards generated daily reports in Portable document format (pdf).
  - New marks cards generated list on day book
  - Duplicate marks generated list on day book
- Redesign of marks cards if needed.
- The module pulls the data from main database directly, once the competent authority of the examination branch approves the marks.
- Edit option should not be available in this module.
- 3 stages in the marks cards printing
  - Pulling of data as per course, semester, subject and year
  - Approval of marks cards and validation if any
  - Final approval and printing
- Posting of data after printing and other features as per the requirement of Examination branch.


